



SciTechsperience Internship Program Student Candidate Guidelines and Eligibility Requirements

Eligibility:

Eligible students must be a Minnesota resident, or living in Minnesota while attending school in Minnesota, currently enrolled in a qualified STEM degree in a higher learning institution, and in good academic standing (2.50 GPA or above). Students must also be currently registered as a tech or community college student (second year or at least 24 credits completed); a junior (at least 60 credits completed – AP courses included); a senior at a four-year institution pursuing a degree with a major in science, technology, engineering, or mathematical sciences; or a student pursuing a graduate degree in a STEM field. Students must be at least 18 years of age when the internship begins.

Guidelines:

Students may post only one application. The student pool will be categorized according to their major/field of study. Applications/profiles will remain active until a 'match' is confirmed or the period of availability has expired. Once a student's application is approved, students may go to SciTechMN.org to identify internships within the SciTechsperience Program that are of interest to them. Students are eligible to receive one SciTechsperience internship per program year (September 1 to August 31).

Candidates are responsible for the accuracy of the information in their profile, submitting a (preferably) certified college transcript to the SciTechsperience Internship Program, providing proof of Selective Service registration or exemption, setting up interviews and, if hired, work arrangements with identified businesses, engaging in and performing internships to the performance standards of the employer, and providing results documentation required by the Program. Further the student shall:

- Immediately report to the SciTechsperience Internship Program (beckys@mhta.org) any termination action associated with the internship, regardless of whether the termination was initiated by the student or company; and
- Provide feedback on the SciTechsperience Internship Program upon completion of internship employment via survey and any additional follow-up reporting as requested MHTA
- Submit a PowerPoint slide that includes a photo of themselves at work with a statement of what they will take away from the internship as requested by MHTA

All data provided through this site for compliance with Program requirements is collected solely for SciTechsperience Internship Program use only. No data regarding gender, race, or economic status is shared with employers, and will only be used in aggregate for fulfillment of grant reporting requirements to the SciTechsperience program's funders.
